

The number of American Indians and Alaska Natives living in the U.S. are growing faster than the U.S. population. In the past 20 years it was doubled, from 3.8 million in 2008 (1.01 percent of population), to 5.2 million in 2013 (2%), to nearly 7 million now. It is projected to 11.2 million in 2060. California has the largest percentage of Native Americans and nearly 55,000 live in Los Angeles. The concept of marriage and the ceremony for Native Americans can vary based on particular tribal beliefs and practices. There also may be different requirements when filing divorce in tribal court, which would vary from tribe to tribe, yet there are no specific pleading or discovery rules regarding Native American spouses in state family law cases.



And under the adversarial nature and environment of the legal proceedings any unfamiliar cultural behavior may be interpreted as disrespect and prejudice toward others.
